



Call for action against MLM Speaker over brutal assault on Kgoshi Mampuru

SCHOONOORD

A Ward Delimitation Outreach meeting turned violent on Wednesday 8 October 2025, at Peter Nchabeleng Community Hall in Schoonoord.

The meeting, chaired by Makhuduthamaga Local Municipality (MLM) Speaker Judy Mphelane-Nkgadima, was intended to facilitate community participation in the consultation on Voting Districts (VDs).

It is alleged that tension arose when Boikie Rantho, the PR Councillor representing the Economic Freedom Fighters (EFF) in MLM, was chosen to ask questions on the presented VDs.

Rantho queried why Jane Furse Comprehensive School VD appeared in both MLM Ward 19 and Ward 20. However, MLM Mayor Merah Mahlase and MLM Ward 21 Councillor Makanyoge Morwamakoti immediately stopped Rantho from participating, citing that he is a councillor and not allowed to participate in the community's platform.

The situation escalated into a physical altercation between Kgoshi Malekutu Mampuru, a traditional leader of Bapedi Ba Maroteng in Mamone and the chairperson of the meeting, Mphelane-Nkgadima, after Mampuru stood up to support Rantho's right to participate.

Allegedly, Mampuru was physically attacked and fell to the ground before being separated by community members.

The incident has sparked outrage in the community, with many demanding harsh action against Mphelane-Nkgadima.

The EFF in MLM has also condemned the incident, saying they will discuss the matter with the EFF Limpopo Provincial Command Team for further steps be taken against MLM Council Speaker.

"We will not let this kind of behaviour go unpunished. We will take action against Mphelane-Nkgadima and Mayor Mahlase for their role in this incident," said Cllr Rantho.

Speakers at the gathering stressed the importance of ensuring the safety and security of traditional leaders and community members.

They called for a thorough investigation into the incident and urged the authorities to take swift action to prevent similar incidents in the future.

MLM Spokesperson, Thomas Mashabela, could not respond to the publication's enquiries at the time of going to press.

"We will not let this kind of behaviour go unpunished. We will take action against Mphelane-Nkgadima and Mayor Mahlase for their role in this incident."

The Sekhukhune District Municipality (SDM) has on Thursday 9 October 2025, officially launched its National Student Financial Aid Scheme (NSFAS) Support Programme at Kgaladi Primary School in Mamone Science Centre at Mamone Village outside Jane Furse.

The programme is set to assist prospective students with applications for the 2026 academic year at various institutions of higher learning, aiming to equip learners with the necessary support to access funding for tertiary education.

Nearly 100 learners were supported during the launch, with active participation from educators, parents, and guardians.

EMLM grader hijacked in Dennilton

The Elias Motsoaledi Local Municipality (EMLM) strongly condemns the criminal incident, following a brazen attack on a municipal grader and its operator, occurred during a routine service delivery operation in Dennilton on Thursday 8 October 2025, at around 10:40 AM.

The municipality said the attack raised serious concerns about the safety of municipal employees and the protection of public assets.

Simon Makua, EMLM Spokesperson, said according to eyewitnesses, unidentified suspects, who were heavily armed, approached the municipal worker, physically assaulted him, and forcefully took control of the grader.

"The employee is currently receiving medical care and trauma support following the incident," he said.

Makua said fortunately, the stolen grader was later recovered at around 9:44 PM on the same day, abandoned at Khalabatla in Soshanguve, Gauteng Province.

"A criminal case has been opened at Dennilton Police Station, and the municipality is working closely with law enforcement authorities to ensure a thorough and urgent investigation is conducted," he said.

The Mayor of EMLM, Cllr David Tladi, strongly condemned the violent attack on the employee and the stealing of the property.

"This grader belongs to the community and plays a vital role

in delivering services that benefit everyone. We urge members of the public to report any suspicious activity. We also call on law enforcement to act swiftly and bring the perpetrators to justice," he said.

Tladi said the municipality appeals to members of the public with information related to the incident to come forward and assist law enforcement agencies.

The safety of municipal employees and the protection of public assets remain a top priority for the municipality.

According to the police, no arrests have been made at this stage, and investigations are underway to determine how the grader was transported and to identify those involved.

Road rehabilitation underway in Sephaku Village

Police officer wanted for murder commits suicide

The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has strongly condemned an incident in which a 53-year-old police sergeant from Riba Cross outside Burgersfort, took his own life after being cornered by police along the R555 road near Burgersfort on Sunday 12 October 2025.

According to the police, preliminary investigations revealed that the deceased, who was attached to the Presidential Protection Service (PSS) in Pretoria, Gauteng, was wanted in connection with a murder and an attempted murder committed in that province.

“It is alleged that on Saturday 11 October 2025, the sergeant fatally shot a female sergeant, also a member of the SAPS in Pretoria, and on Sunday morning, 12 October 2025, he shot and wounded his wife in Bronkhorstspuit, Gauteng,” explained Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson.

Ledwaba added that following intelligence investigation about his movements, Limpopo police intercepted the white Nissan NP 200 vehicle he was driving.

“The suspect allegedly fired a shot towards police officers and, when cornered, turned the firearm on himself. The firearm used was confirmed to be a state-issued service pistol,” Ledwaba said.

He said an inquest case has been opened, and the Independent Police investigative Directorate (IPID), has been informed for further investigation.

Lieutenant General Hadebe has condemned the incident, expressing deep concern over the continued loss of lives due to domestic-related violence, particularly involving law enforcement members.

“This tragedy once again highlights the urgent need for members to seek help when facing personal difficulties. We remain committed to supporting the well-being of our members while upholding the rule of law,” said Hadebe.

Limpopo Police Commissioner condemns corruption within SAPS ranks



The five police officers, Sergeant Lucky Shogolo, Constable Thapelo Ledwaba, Constable Malesela Huma and Constable Saraphina Senama, all attached to various units in Limpopo Province during their appearance before the Mashishing Magistrate's Court.

LIMPOPO - The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has strongly condemned the conduct of the province's four SAPS members and one civilian who were arrested in Lydenburg, Mpumalanga, in connection with a house robbery that occurred on Thursday night 9 October 2025.

According to preliminary reports, the victims, all Ethiopian nationals, were asleep when they were ambushed by the suspects. The suspects, who were using a marked Limpopo SAPS vehicle and a Toyota bakkie, allegedly robbed the victims of an undisclosed amount of cash and illicit cigarettes worth R1.5 million.

The private vehicle (Suzuki/Avanza) reportedly fled the scene carrying multiple boxes of suspected illicit cigarettes and an undisclosed amount of cash.

Police members from Lydenburg SAPS responded urgently to a report of house robbery in progress at a block of flats in the area. Upon arrival, officers were shocked to find a police-branded vehicle from the

Limpopo Flying Squad at the scene. Four occupants all attached to various Limpopo SAPS Units, were arrested at the scene, three male SAPS members and one female member.

They were identified as Sergeant Lucky Shogolo (40), Constable Thapelo Ledwaba (34), Constable Malesela Huma (34) and Constable Saraphina Senama (34).

A civilian suspect, Sello Komane (29), was also detained. Both the marked police vehicle and the Toyota bakkie were seized.

"We wish to reiterate that acts of criminality and corruption within the ranks of the police will not be tolerated. The arrest of these members will send a strong message that anyone engaging in corrupt elements will swap their blue uniform to orange," said Hadebe.

They appeared before the Mashishing Magistrate's Court on Monday 13 October 2025, facing charges of house robbery.

They were remanded in custody and their formal bail application is scheduled for Friday 17 October 2025.

Dennilton Police launch manhunt for business robbery suspects

The Police in Dennilton have launched a manhunt for suspects involved in a business robbery incident that occurred on Thursday 9 October 2025, at around 08:20 AM at a shop in Moutsiya Mall. Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said according to the information, one of the suspect entered the shop pretending to be a customer, drew a firearm, and ordered occupants to keep quiet, demanding money.

"The suspect took an undisclosed amount of cash and approximately 20 cellphones from the store safe. A second suspect joined the robbery, and both suspects fled the scene on foot," explained Ledwaba.

He said the police have opened a case of business robbery and are working to identify and apprehend the suspects.

This latest incident follows two separate business robbery

incidents that occurred on Friday evening on 3 October 2025, in Kirkvorsfontein Village and Moutsiya Mall.

During one of the previous incidents, an armed robbery occurred at Kirkvorsfontein Village at approximately 20:30, an unknown man entered a tavern, pulled out a firearm, and demanded money. A second armed suspect joined, ordering the victims to sit down. The robbers escaped with an undisclosed amount of money and a tablet phone.

In another recent armed robbery occurred at Moutsiya Mall Robbery on 3 October 2025, at around 19:49, a supermarket in Moutsiya Mall was targeted by five suspects. One suspect overpowered the security guard, allowing his accomplices to enter the store. The group threatened employees, ordering them to lie down, and stole an undisclosed amount of cash and cigarettes.
