## Police van shortage leaves Dennilton community vul-nerable to crime

#### **DENNILTON**

he community of Dennilton and surrounding villages in Elias Motsoaledi Local Municipality (EMLM) are reeling from a crippling shortage of police vehicles, leaving residents feeling vulnerable to rampant crime and infrastructure vandalism.

In an open letter to Limpopo Premier Dr Phophi Ramathuba, concerned resident, Mabilo Nkadimeng, pleaded for urgent intervention, allegedly citing the Dennilton Police Station's solitary functioning police van serving over 58 villages.

"The persistent shortage of police vehicles at the Dennilton SAPS has reached a critical point, making a mockery of community safety and weakening the fight against rampant crime," Nkadimeng wrote.

He said the shortage has emboldened criminals, who are targeting critical includina infrastructure, Eskom cables, boreholes, and water pump machines, further exacerbating the community's suffering.Nkadimeng's letter highlighted a recent incident where EMLM Ward 14 Councillor, Marang Phokwane was unable to report a borehole vandalism incident at Matlala Lehwelere Village due to the station's lack of vehicles.

"We are worried because only one police van is functional

in Dennilton Police Station. We appeal to the Premier's office to urgently intervene by allocating additional police vehicles to Dennilton SAPS, assess the broader resourcing gaps across police stations in the Sekhukhune District, and engage SAPS provincial leadership to prioritise Dennilton as a high-need area," Nkadimeng urged.

He furthered indicated that other increased crimes escalated by lack of police patrols include armed robberies, house break-ins and business robberies, which are also mainly caused by lack of response to emergencies due to limited resources.

"In this scenario, criminals are targeting homes at night, breaking doors, threatening residents with weapons, and stealing valuables. Residents are urged to remain vigilant and join volunteer patrol teams to protect their homes and shared infrastructure," appealed Nkadimeng.

Nkadimeng pleaded with Premier Ramathuba to intervene and restore safety, dignity, and trust in the public, adding that the community is willing to cooperate fully with law enforcement through community policing forums and volunteer patrol teams.

At the time of going to press, Limpopo Provincial Police Spokesperson, Colonel Malesela Ledwaba, could not yet respond to the publication's enquiries.

On Thursday 13 November 2025, the Sekhukhune District Municipality (SDM) convened its First Quarter Lekgotla of the current financial year, bringing together political heads and administrative arm to deliberate on mechanisms to enhance service delivery efficiency, economic development, and governance reform.

## Two A.M. Masehego School learners died in a car accident

#### **MONSTERLUS**

A devastating road accident, which occurred in the afternoon of Friday 14 November 2025, has claimed the lives of three learners from A.M. Mashego Secondary School in Monsterlus, Sekhukhune South Education District.

According to reports, the accident occurred between the Hlogotlou Police Station and Onane Primary School, near Zama Zama Secondary School in Monsterlus, when the bakkie they were travelling in allegedly lost control and overturned with the five learners who were returning from school.

During the accident, Blessing Mokoana and Bongani Mathibela, both learners at A.M. Mashego Secondary, died at the scene, while three other learners, Calvin Makola, Moiakgomo Mohlahlo and Herbert Mokaba were critically injured and rushed to St Rita's Hospital in Glen Cowie.

According to Mosebjadi Kgaffe, Limpopo Department of Education Spokesperson, preliminary investigations suggest that two grade 10 learners and one each from grades 9, 11 and 12 were returning from an examination session when the accident occurred.

"The Grade 12 learner, who was driving the vehicle, which was allegedly provided by his parents, was running late for the exam earlier in the day. Authorities are currently investigating the cause of the accident," she said.

Limpopo Education MEC, Mavhungu Lerule-Ramakhanya, has expressed her deepest



## Suspected stock thieve nabbed in joint police operation

#### **STOFFBERG**

A joint intelligence operation conducted by the police in Limpopo and Mpumalanga Provinces has led to the arrest of a male suspect for possession of suspected stolen property, including eleven goats and a motor vehicle.

The operation, carried out by members of Sekhukhune District and Roosenekaal SAPS in collaboration with Laersdrift SAPS, took place at the Stoffberg Traffic Weigh Bridge in Mpumalanga Province on Friday 14 November 2025.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said according to reports, the suspect was arrested after information was received about his possession of suspected stolen property.

The vehicle, a Nissan NP200 bakkie with Mpumalanga Province registration number plate, was spotted driving near the weigh bridge and was pulled over

"The suspicious motor vehicle was found loaded with eleven goats suspected of being stolen. The suspect failed to provide proof on the origin of the property, leading to his arrest at the scene," said Ledwaba.

He added that police preliminary investigations indicate that the vehicle was reported stolen at Akasia SAPS in Pretoria North, and the suspect has been linked to several other cases.

"The suspect will appear before the Jane Furse Magistrate's Court soon, facing charges of possession of suspected stolen property and stock theft. The vehicle has been seized and will form part of the investigation, investigations continue," Ledwaba said.

### Dennilton man gets life imprisonment for raping a 13-year-old girl

GROBLERSDAL - A 25-year-old man, who cannot be named to protect the identity of the victim, has been sentenced to life imprisonment by the Groblersdal High Court on Tuesday 11 November 2025, for the rape of a 13-year-old girl, the police said.

According to Lieutenant Colonel Masekela Magoro, Limpopo Provincial Police Spokesperson, the incident occurred in December 2016 when the victim was visiting her aunt in Dennilton, where the accused resided.

"The accused raped the victim on two separate occasions, in December 2016 and April 2017, and threatened her not to report the incidents. The victim eventually informed her cousin about the abuse, leading to the arrest of the suspect. A rape case was opened with SAPS

Dennilton, and the matter was transferred to the Groblersdal Family Violence, Child Protection and Sexual Offenses (FCS) Unit," explained Magoro.

He said following his arrest, the accused was convicted and sentenced on Tuesday 11 November 2025, after appearing in court on several occasions.


Magoro said the accused was initially not granted bail during his trial until he was convicted and sentenced.

The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, welcomes the conviction and sentencing of the accused.

Hadebe said the sentence serves as a reminder that the police remains committed to fighting crimes, particularly those committed against women and children.

### **Woman murdered** in Carolina, suspect arrested in Zaaiplaas

**ZAAIPLAAS** – A police collaboration from Limpopo and Mpumalanga Provinces has on Thursday 13 November 2025, led to Spokesperson. the arrest of a 42-year-old man at Zaaiplaas murder of a 26-year-old woman who was brutally killed at Kromkrans Village in Mpumalanga on Saturday 1 November

According to the police, the victim, Nokuhle Lethukuthula Malaza (26), was reported missing on 6 November 2025, five days after she was last seen leaving a local tavern with the 42-year-old male suspect.

"The two were reportedly seen leaving a local tavern together, but since that evening, the woman never returned home, while the male friend was seen back in the area alone. Family members and community members from Kromkrans demanded answers from the man regarding Nokuhle's whereabouts. The suspect allegedly fled the area and went to hide at his sister's house in Sikhululile Village, Mafube Section,

Arnot," explained Lieutenant Colonel Jabu Ndubane, Mpumalanga Provincial Police

He said preliminary investigations by outside Monsterlus in connection with Carolina Detectives led them to Arnot, where they were informed that the suspect had been taken to Middelburg Hospital.

"On Monday 10 November 2025, the police proceeded to the hospital, where they were told that the suspect had been transferred to Witbank Hospital for specialist treatment. On Wednesday, 12 November 2025, members of the Kromkrans community blocked the roads, demanding the suspect's arrest. Carolina SAPS management urged the community to remain calm, assuring them that the investigation was progressing," informed

He said the police later returned to Middelburg Hospital and learned that the suspect had been discharged the previous

Limpopo MEC for Transport and Community Safety, Violet Mathye, has recently instructed the Head of Department (HOD), Stephen Matjena, to conduct a highlevel investigation into a horrific crash that of the victims. claimed the lives of six people, including five immediate family members.

The accident occurred on Thursday 6 November 2025 at Mopetsi Bridge in Diphale Village outside Burgersfort, Fetakgomo Tubatse Municipality (FTLM).

The crash, which involved a double cab van with eight occupants, allegedly occurred when the driver lost control of the vehicle, causing it to veer off the road.

Five of the six deceased were immediate family members sharing the same surname, making the tragedy even more heartbreaking.

The accident cause devastation to Bafedi Conceliah Maroga, a general worker at the Infrastructure and Water Services Department (IWS) in Sekhukhune District Municipality (SDM), who tragically lost six loved ones.

Maroga lost two children, three grandchildren, and a son-in-law in the

horrific car accident. The two injured occupants were transported to nearby hospitals for treatment.

MEC Mathye expressed her sadness and condolences to the families and next of kin

"These are difficult times, especially for the family who lost five immediate members. On behalf of the department, I wish to convey sincere condolences to the families and next of kin, and I wish the injured a speedy recovery," she said.

The MEC said the investigation into the crash will be conducted in conjunction with the Road Traffic Management Corporation

"The investigation into the crash aims to determine the circumstances surrounding the tragic event," she said.

MEC Mathye thanked the Executive Mayor of Sekhukhune, Cllr Minah Bahula, and her collective for their leadership during this difficult period.

She advised that as the Festive Season approaches, her department will continue to deploy more traffic officers to reduce road carnage and furthered urged all road users to prioritize road safety.

driven operations, the team traced the suspect to Zaaiplaas Village outside Groblersdal, Limpopo. With the assistance of Hlogotlou and Groblersdal SAPS members, information was gathered indicating that the suspect was end route to Monsterlus. The team proceeded there and found him with his luggage, waiting for transport. He was immediately arrested and transported back to Carolina SAPS," explained Ndubane.

He added that during questioning, the suspect allegedly stated that he assaulted his girlfriend with a beer bottle and left her unconscious.

"A pointing-out was conducted, during which the suspect led police to a bushy area on a farm between Chrissiesmeer and Carolina. There, police discovered the naked and decomposed body of the deceased," said Ndubane.

He said the suspect is expected to appear before the Chief Albert Luthuli Magistrate's Court soon, facing a charge of murder.

"The police are continuing their investigation, and the suspect's alleged vehicle has been impounded for further examination," said Ndubane.

Gogo Mahlangu was a remarkable woman who captured the hearts of many South Africans with her strength, courage, and resilience in the face of unimaginable adversity.

She was subjected to a horrific act of gender-based violence at the age of 101, but chose not to be defined by her pain.

The perpetrator of the heinous crime was sentenced to life imprisonment for rape and an additional three years for housebreaking.

Premier Dr Ramathuba commended the South African Police Service investigating team, led by Warrant Officer Phala, for their dedication and professionalism in ensuring justice was served.

"We are deeply saddened by the passing of 102-year-old Gogo Mahlangu, and we join the Mahlangu family and the entire Zaaiplaas community in mourning this remarkable woman. When we visited her during her 102nd birthday celebration, we were inspired by her courage and the warmth she radiated despite all she had endured. Little did we know that it would be our final interaction with her. May her gentle soul rest in eternal peace," said Premier Ramathuba.

Premier Dr Ramathuba also applauded the judiciary for acting decisively to ensure the perpetrator faced the full might of the law. Gogo Mahlangu passed away just a month after the sentencing, having lived long enough to witness justice being done in her case.

The Premier extended her appreciation to the Mahlangu family and the Zaaiplaas community for their love and support, and called on society to honour Gogo Mahlangu's legacy by standing firm against all forms of gender-based violence.
