



# DA Limpopo calls for action to address Limpopo Water Crisis

## SEKHUKHUNE

The Democratic Alliance (DA) in Limpopo raised concerns about the province's dire water crisis, with Lindy Wilson, DA Provincial Spokesperson for Cooperative Governance, Human Settlements and Traditional Affairs (COGHSTA), calling for immediate action to address the issue.

Wilson said this call for action comes after the South African Human Rights Commission (SAHRC) found in 2023 that all 10 WSAs in Limpopo were non-compliant with the Water Services Act and Compulsory Standards.

The Commission also noted that the Department of COGHSTA, the Office of the Premier, and the National Department of Water and Sanitation failed in their oversight responsibilities.

According to Wilson, Limpopo's 10 Water Service Authorities (WSAs) are in major distress, with a staggering 42% vacancy rate in critical positions.

"Of the 4059 posts required at our WSA's, 1711 are vacant. This shortage of skilled personnel is compounded by financial woes, with six of the 10 municipalities in which the WSAs are vested facing financial distress," she said.

Wilson indicated that this human resources skills and capacity crisis in the WSA's are compounded by the fact that 6 of the 10 municipalities, in which the WSA's are vested, are in financial distress.

"The municipalities are Mopani, Vhembe and Sekhukhune Districts, as well as Thabazimbi, Modimolle-Mookgophong and Mkgalakwena Local Municipalities. Sekhukhune is the only district municipality with a funded budget; the unfunded four districts cannot indicate how they will fund their expenses and have ineffective billing systems," she said.

Wilson informed that the situation is further exacerbated by incomplete bulk infrastructure projects, with remnants of abandoned projects scattered across the province.

"Remnants of incomplete bulk infrastructure projects are strewn across the province with 24 new, but incomplete projects implemented since 2023," Wilson noted.

She added that the DA is particularly concerned about the lack of access to piped water in Limpopo households, with 20.5% of households lacking access to this basic service, compared to the national average of 8.7%.

"It is clear that the ANC government in Limpopo does not have the capacity, nor the will to save our communities from the indignant suffering of a life without water," Wilson said.

The DA is calling on the MEC for COGHSTA, Basikopo Makamu, to submit corrective action plans with binding timelines to address the collapse of water infrastructure in the province.

"We demand that the MEC takes immediate action to address the water crisis in Limpopo," Wilson emphasized.

# Police in Limpopo net 822 suspects during Operation Shanela



Illegal drugs were confiscated by the law enforcement agencies during Operation Shanela conducted in Limpopo from Monday 27 October to Sunday 2 November 2025.

The recent Multi-Disciplinary Operation, which involved various law enforcement agencies, has resulted in the arrests of more than 800 suspects across Limpopo Province.

## SEKHUKHUNE

The Police in Limpopo has arrested 822 suspects through Operation Shanela, a high-density multi-disciplinary operation conducted in all five districts of the province.

The operation, which took place from Monday 27 October to Sunday 2 November 2025, resulted in the arrest of suspects for various crimes, including murder, rape, possession of unlicensed firearms, malicious damage to property, and burglary.

According to Brigadier Hlulani Mashaba, Limpopo Provincial Police Spokesperson, the operation was a success, with 822 suspects arrested and a range of items confiscated, including four firearms, 437,389 litres of alcoholic beverages, six

dangerous weapons, 1.02 kg of drugs, and 0.123g of cocaine.

The operation involved various law enforcement agencies, including traffic police from both provincial and municipalities, the Department of Home Affairs, Border Management Authority, the Community Policing Forum, and private security companies.

"The actions conducted during the operation included stop and searches, roadblocks, high visibility patrols, vehicle checkpoints, and licensed liquor premises inspections," explained Mashaba.

He added that some of the notable arrests include 16 suspects arrested for possession of drugs, seven for possession of illegal cigarettes, 21 suspects arrested for rape, and 66 apprehended for assault common. Additionally, 38

unlicensed liquor premises were closed, and 411 premises were searched.

"The police are urging residents to report any suspicious activity to the authorities. All suspects are expected to appear before their respective courts across the province," Mashaba said.

Acting Provincial Commissioner of the Police in Limpopo, Major General Jan Scheepers, has welcomed the arrests and commended the members and all stakeholders who participated during the high-density operations.

"These operations will be intensified to ensure the safety of residents, businesses, and visitors during this heightened festive season period and beyond," he said.

## Suspect nabbed with unlicensed firearm in Luckau, Zaaiplaas man arrested for rape in separate incident

### LUCKAU/ZAAIPLAAS

The Hlogotlou Police have arrested a 27-year-old male suspect for possession of unlicensed firearm and ammunition, which had been reported stolen at Modimolle.

The arrest was effected by the Sekhukhune District Tracking and Investigation Team in the early hours of Monday 3 November 2025, at Luckau Village outside Groblersdal, Hlogotlou policing area.

According to Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, the suspect attempted to flee from police near a local tavern but was apprehended.

He said the suspect is

expected to appear before the Nebo Magistrate's Court soon facing charges of possession of unlicensed firearm and the investigation into the matter is continuing.

Meanwhile in a separate incident, the Police in Zaaiplaas near Monsterlus have arrested a 29-year-old male suspect in connection with a rape incident that occurred at a local tavern in the early hours of Sunday 2 November 2025.

Brigadier Hlulani Mashaba, Limpopo Provincial Police Spokesperson, said according to the information, the 27-year-old female victim was at a tavern in Zaaiplaas when the suspect allegedly grabbed her, pushed her to the ground,

sexually assaulted her by forcefully inserting his finger into her private parts.

"The victim was taken to a local hospital for medical examination and treatment. The police subsequently opened a case of sexual assault and the suspect was swiftly arrested," explained Mashaba.

He said the suspect is expected to appear before the Zaaiplaas Magistrate's Court soon, facing a charge of sexual assault.

Acting Provincial Commissioner of the Police in Limpopo, Major General Jan Scheepers, has strongly condemned the incident and welcomed the arrest.

## Serial rapists gets 125 years behind bars

**MANAPYANE** - A 32-year-old man, Mahlatse Tolonyane Matebane, from Manapyane Village outside Marble Hall, has been sentenced to 25 years direct imprisonment for a series of violent crimes committed across the Sekhukhune District.

The Polokwane High Court convicted Matebane on nine counts, including rape, attempted murder, robbery, housebreaking, and possession of unlicensed firearms and ammunition.

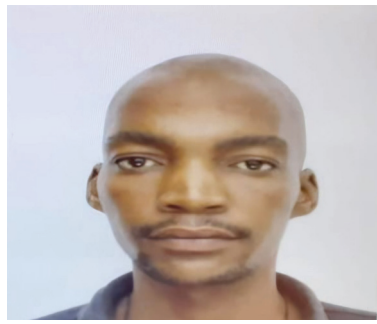
According to Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, Matebane committed the crimes between 2020 and 2023 in the Motetema, Rakgoadi, and Dennilton policing areas. "The sentence follows extensive investigations conducted by Detective Sergeant Raymond Phago, attached to the Sekhukhune District Investigation and Tracking Task Team, who successfully linked the accused to several cases," said Colonel Ledwaba.

Ledwaba said during the trial, the court heard harrowing details of Matebane's crimes.

"On 10 August 2020, the accused attacked a 20-year-old woman from Motetema, blaming her for reporting him to the police, dragging her into nearby bushes, threatening to kill her, and raping her. In another incident on 15 September 2020, Matebane attacked an 18-year-old schoolgirl in Rakgoadi, threatening her with a firearm, forcing her into nearby bushes, and raping her before fleeing into the mountains," explained Ledwaba.

He added that Matebane continued with his reign of terror where on 13 February 2021, he shot a 32-year-old man multiple times at a tuckshop in Mafisheng Village after a brief altercation. The victim managed to escape and later sought medical assistance at a local hospital.

Ledwaba said the court imposed 125 imprisonment for different counts including rape, attempted rape, housebreaking with intent to rape, robbery with aggravating circumstances and possession of an unlicensed firearm ammunition and escaping from lawful custody in Dennilton.

The Acting Provincial Commissioner of Police in Limpopo, Major General Jan Scheepers, commended the investigating officer and all members involved in ensuring that justice was served.

"This sentencing sends a clear message that gender-based violence and acts of brutality will not be tolerated. The dedication of our investigators in linking the accused to multiple cases is commendable and demonstrates our unwavering commitment to protecting vulnerable members of our communities," said Major General Scheepers.

## Family of murdered cousins calls for justice and harsh sentence

### LUCKAU

The grieving family of two cousins murdered in Mamelodi is demanding justice and a harsh sentence against the perpetrator. 22-year-old Tshiamo Moramaga and 21-year-old Baleseng Moramaga were found with gunshot wounds on Sunday 26 October 2025.

Their funeral service was held at Luckau Village outside Groblersdal on Saturday 1 November 2025.

The cousins, who were studying at the University of South Africa (UNISA), were eagerly anticipating the festive season and their final exam results.

Family spokesperson, Edward Moramaga, described the cousins as inseparable, saying they "lived

like twins their entire life as they were always together."

The family has expressed their deep sorrow and frustration over the brutal killing, with Moramaga calling for a harsh sentence for the accused. "We want justice for our daughters," he emphasized.

A 38-year-old man, Tebogo Mnisi, has been arrested in connection with the murders. According to the police, Mnisi allegedly shot the cousins after they declined his advances at a nearby entertainment venue.

The suspect, who was reportedly heavily intoxicated at the time, became violent and pursued the cousins, shooting them both. The third victim, a young male who was in company of the slain cousins, is recovering in hospital after sustaining

gunshot wounds.

Mnisi was arrested at a filing station in Pretoria and faces charges of premeditated murder, attempted murder, and possession of an illegal firearm.

He abandoned his bail application in the Mamelodi Magistrate's Court and will remain in custody until the case returns to court in January 2026.

The National Prosecuting Authority (NPA) has condemned the killings and reiterated its stance against gender-based violence and femicide.

The community has also rallied behind the family, demanding justice for the victims.

As the family mourns the loss of their loved ones, they are calling for the harshest sentence possible against Mnisi.

# Dullstroom Road accident victims laid to rest in Kgautšwane

**KGAUTŠWANE** – Five of six car crash victims from Fetakgomo Tubatse Local Municipality (FTLM), who died in a devastating car accident on the R540 Dullstroom Road, were laid to rest on Saturday 1 November 2025 during a mass funeral in Kgautšwane Village FTLM Ward 24.

The tragic incident occurred on Sunday 26 October 2025, and has prompted an outpouring of condolences from local leaders and residents.

According to reports, the accident involved a GWM Sport Utility Vehicle (SUV) and a minibus taxi in a T-bone collision.

All six victims, who died at the scene, were passengers in the taxi. Eight people sustained serious injuries, including seven passengers and the SUV driver.

The Mpumalanga Department of Community Safety, Security and Liaison has urged motorists to exercise greater vigilance to prevent further loss of life on the province's roads.

"We remain deeply concerned by the number of fatalities caused by road crashes that could be avoided with more responsible

driving," said Mpumalanga MEC for Community Safety, Security and Liaison, Jackie Macie.

FTLM Mayor, Cllr Eddie Maila, attended the mass funeral to pay final respects to the victims.

The mayor was accompanied by members of the Executive Committee, including Cllr Queen Moeng who is FTLM MMC for Budget and Treasury, and FTLM MMC for Technical Services Cllr Halinda Mojalefa.

Addressing the mourners, Mayor Maila expressed deep sorrow and offered support to the grieving families on behalf of the municipality and its residents.

"We came here today because our community is grieving. As government, we must always draw closer to our people,

especially in moments of sorrow to comfort, support and mourn with them. We are government because of the people," he said.

The mayor emphasized the importance of responsible driving, urging taxi associations and all motorists to obey road regulations and drive responsibly to minimize road fatalities.


"While the days of a person's life are determined by God, every driver must remember that they carry precious lives," he said.

### AN UPDATE ON BULK WATER SUPPLY FROM THE CITY OF TSHWANE METROPOLITAN MUNICIPALITY AND PUBLIC HEALTH ASSURANCE

Thembisile Hani Local Municipality (THLM) is aware of recent media reports regarding a **typhoid fever outbreak** under investigation in parts of Gauteng, including Hammanskraal and Bronkhorstspuit.

Whilst the City of Tshwane (CoT) remains one of the bulk water suppliers to THLM, the last date of the supply of water is the 10th of October 2025, and there is no water currently supplied to THLM due to on-going refurbishment works at the Bronkhorstspuit Water Treatment Works (WTW).

THLM continues to supply water from Rand Water, the Bundu WTW, and internal Borehole Schemes, and the treated water is disinfected to eliminate harmful microorganisms before distribution.

Our recent (October 2025) microbiological test results from an accredited laboratory confirm that:

- E.coli was absent in most samples in line with SANS 241 standards.
- Total coliform levels remained within acceptable limits.
- All treated water from Bundu WTW and reservoirs complied with national drinking water standards.

The above is therefor reassurance that the water supplied to residents by THLM remains safe for human consumption and household utilisation.

On a note of continued precaution, the public is advised to:

- Store drinking water in clean, covered containers.
- Wash hands before eating or preparing food.
- Report any water discoloration or odour to the Municipality.
- Seek medical attention if experiencing symptoms such as fever, headaches or abdominal pains.

THLM remains committed to ensuring safe drinking water for all, and the community will be informed on developments bulk water supply from the CoT.

## EFF Sekhukhune hails recent SDM Council resolutions



EFF Councillor in SDM, Ali Maloba, says the party is pleased with the recent SDM Council resolutions which are set to probe alleged corruption between the district municipality and LNW Scheme.

The Economic Freedom Fighters (EFF) in Sekhukhune District Municipality (SDM) is hailing a recent council resolution that seeks to investigate an allegedly illegal contract between the municipality and Lepelle Northern Water Scheme (LNW).

According to Ali Maloba, EFF Councillor in SDM, the council resolutions, taken on Thursday 30 October 2025, are a step in the right direction.

Part of the resolutions, the council resolved to launch investigation into contract entered into with LNW Scheme as soon as possible.

The council also resolved to probe alleged outstanding multi-million-rand invoices without evidence of projects done or completed by Lepelle Water Board.

Maloba stated that the SDM council agreed that they will

also demand certificates of project completion submitted by LNW Scheme be investigated, while officials and the legal advisor responsible for signing the alleged illegal contract will be held responsible, including involved political leadership.

"As the Economic Freedom Fighters Sekhukhune District Caucus, we will continue protecting the public purse by exposing hidden organised corruption committed by state organs," Maloba said.

Maloba indicated that the EFF has noted that Northern Lepelle Water Board continues to invoice Sekhukhune District Municipality for jobs not done, with "ghost invoices" being a major concern.

"The party has welcomed the council's decision to challenge and revoke the Memorandum of Understanding (MOU) between the municipality and Lepelle Northern Water Scheme," he said.

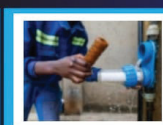
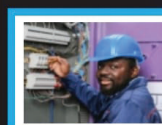

Water infrastructure failures  
spark outrage in Sekhukhune



Residents of Ga-Moloi Village in Makhuduthamaga Municipality say they are not happy with SDM's incomplete water projects. The community say they are demanding accountability and transparency on the stagnated projects.

**GA-MOLOI** - Residents of Ga-Moloi Village outside Jane Furse in Makhuduthamaga Local Municipality (MLM) Ward 10, are infuriated over the alleged repeated failure of water infrastructure projects in Sekhukhune.

Residents claim despite numerous initiatives by Sekhukhune District Municipality (SDM) over the past two decades, the community still lacks reliable access to water.

According to a community leader, Katlego Mnisi, three major water projects have been launched, but none have been successfully completed or delivered sustainable access to water.

The projects include installation of water pipes and taps in the 2002/2003 financial year, but none of them ever worked. "The project was abandoned without accountability," Mnisi said.

He added that another water project, consisting of a new set of taps was installed, but only a few are functional.

"The majority of the taps remain dry, and the community still lacks reliable water access," informed Mnisi.

He said in 2022, the district municipality promised to install boreholes following public disputes with former Executive Mayor Stanley Ramaila. However, the boreholes were drilled but never completed or equipped. The excuse given was "too much clay," yet no alternative solution was provided.

"The situation is further complicated by the damaged main pipeline that once supplied water to St Ritas Hospital. The pipeline has been lying in disrepair for years, and water is now delivered by trucks, raising serious concerns about cost, sustainability, and corruption," said Mnisi.

Mnisi has called for a full forensic audit of all three water projects, including the borehole initiative and the St Ritas pipeline.

"We demand answers, accountability, and action. Water is a basic right, not a political promise. We need transparency and accountability in all future water infrastructure planning," he said.

Mnisi said residents also demand a public disclosure of all procurement records, contractor names, and payments made.

"We will not be silenced. We will continue to demand our rights and hold our leaders accountable. It is time for action, not promises," he said.

The SDM is yet to respond to enquiries sent by the publication.
